1. Passport Copy of Foreigner
2. Driving License or Resident Card of Foreigner
3. Bank Statement
4. Passport Size Photograph (Via Email)
5. Utility Bill (Electricity Bill or Telephone Bill etc)
6. Mobile Number and Email id
7. Documents of Foreign Must be Notarized and Apostle
8. Indian Address for Company & One Indian Director Details

Minimum Requirement for Foreign Owned Company Registration:

1. One Indian Resident Director.
2. Indian Address for Company
