



Proposal for “Shop and Establishment Act (Gumasta) Registration”

➤ **State Wise Shop Establishment Registration Rules (Different Names)**

Here’s a breakdown of states in three types based on the type of license or certificate required:

Type 1: Shop Establishment Certificate –Andhra Pradesh, Gujarat, Himachal Pradesh, Delhi, Manipur, Nagaland, Tamil Nadu etc.

Type 2: Trade License – Assam, Bihar, Chhattisgarh, Haryana, Jharkhand, Karnataka, Madhya Pradesh, Meghalaya, Mizoram, Odisha, Punjab, Sikkim, Telangana, Tripura, Uttar Pradesh, Uttarakhand, and West Bengal.

Type 3: Gumasta License – Maharashtra

➤ **Commercial:**

Shop and Establishment Act (Gumasta) Registration **Charges Rs. 8,000/-**

➤ **Documents Requirement for Shop and Establishment Act (Gumasta) Registration:**

A. Manager/Director/Owner/Partner Documents:

1. PAN Card
2. Aadhar Card
3. Photo
4. Residential Address Proof
5. Mobile and Email id
6. Cancelled Cheque

B. Business Place Documents:

1. Office/Shop Address – Rent Agreement (if rented)
2. Shop/Office – Property Tax Bill or Index Copy or Registry Agreement (Any One)

3. Premises/Office/Shop – Photo with Board

C. Company Documents (if any):

1. PAN Card of Business
2. Partnership Deed/MoA-AoA
3. Company Registration Certificate
4. Any Other Proof if available

➤ **Types Shop and Establishment Act (Gumasta) Registration:**

- **Shop Establishment Registration – Form A:** If a company has 10 or more employees, the employer must register under the Shop Act by submitting an application in Form-A.
- **Shop Establishment Intimation – Form D:** If a company or business has fewer than 10 employees, they must submit an intimation application in Form-D.
