### **Minimum Requirement for Food License Formation:**

**Basic License:** For turnover below ₹12 lakh with photo, ID, address proof, and food safety declaration.

**State License:** For turnover ₹12 lakh–₹20 crore with Form B, layout plan, partner list, ID/address proof, premises proof, NOC, and water report (if needed).

**Central License:** For turnover above ₹20 crore or multi-state business with all State documents, IEC code, machinery details, raw material source, and authorization letter.

**Hygiene Requirement:** Business premises must follow FSSAI hygiene and sanitation standards.

Eligibility: Applicant must have no criminal record related to food safety.

**Validity:** License valid for 1–5 years and must be renewed before expiry.
