Minimum Requirement for Income Tax Audit Service Formation:

- Business: Mandatory if turnover exceeds ₹1 crore.
- Professionals: Mandatory if gross receipts exceed ₹50 lakh.

Declared Profit:

- For businesses under presumptive scheme audit if profit < 8% of turnover.
- For professionals audit if profit < 50% of receipts.
- Conducted by: Only a Chartered Accountant in practice.
- Audit Report Forms: 3CA/3CB and 3CD.

Annual Compliance of Income Tax Audit Service (to be followed every year):

Every financial year, businesses and professionals covered under Section 44AB of the Income Tax Act must comply with tax audit requirements. The process includes:

- Maintaining Proper Books of Accounts As per Income Tax rules and accounting standards.
- 2. Preparation of Financial Statements Profit & Loss Account, Balance Sheet, and related schedules.
- 3. Verification by Chartered Accountant Only a CA in practice can conduct and certify the audit.
- 4. Filing of Tax Audit Report Report to be furnished in Form 3CA/3CB and Form 3CD before the due date (generally 30th September of the assessment year).
- 5. Filing of Income Tax Return (ITR) Along with the audit report and relevant disclosures.
- 6. Preservation of Records Maintain audit and accounting records for future verification or assessment.
