## **Minimum Requirement for Income Tax Return Filing Formation:**

- 1. Income exceeds limit:
- 2. Below 60 yrs ₹2.5 lakh
- 3. 60–80 yrs ₹3 lakh
- 4. 80+ yrs ₹5 lakh
  (₹3 lakh for all under new regime)
- 5. **Even if income < limit**, file ITR if you:
- 6. Deposit ₹1 crore+ in current account
- 7. Spend ₹2 lakh+ on foreign travel
- 8. Pay ₹1 lakh+ electricity bill
- 9. Have foreign assets/income
- 10. Want TDS refund or carry forward loss
- 11. Are a director, partner, or company/LLP
- 12.NRIs if Indian income > ₹2.5 lakh or capital gains from India.

### Annual Compliance of Income Tax Return Filing (to be followed every year):

- 1. Maintain income & expense records
- 2. Collect Form 16, Form 26AS / AIS / TIS
- 3. Compute total income from all sources
- 4. Claim eligible deductions & exemptions
- 5. Pay self-assessment or advance tax (if any)
- 6. File ITR before 31st July (individuals)
- 7. e-Verify ITR within 30 days
- 8. Keep ITR-V acknowledgment safely
- 9. Respond to any IT Department notices
