#### **Commercial:**

#### **PF ESIC Monthly Return Filing Package**

- 1. Up to 20 Employee Rs.2000/-
- 2. Up to 40 Employee Rs.3000/-
- 3. Up to 100 Employee Rs.5000/-
- 4. More than 100 Employee Rs. 7500/-

### **Documents Requirement for PF ESIC Registration:**

- 1. Photograph of Partners
- 2. PAN Card of Partners
- 3. Aadhar Card of Partners (or Any One Election Card/Driving License
- 4. Latest Saving Account Bank Statement of partners
- 5. Telephone Number and Email of Partner
- 6. Proof of Address for Registered Place of LLP (Latest Utility Bill Required)

#### Minimum Requirement for PF ESIC Registration Formation:

- a. Mandatory if 20+ employees.
- b. Voluntary if fewer than 20.
- c. Covers employees earning ≤ ₹15,000/month.
- d. Employer & employee each contribute 12% of basic + DA.
- e. Register online via EPFO portal / AGILE-PRO-S form.
- f. Mandatory if 10+ employees (some state -20).
- g. Covers employees' earnings ≤ ₹21,000/month.
- h. Employer contributes **3.25%**, employee **0.75%** of wages.
- i. Register online via **ESIC portal / AGILE-PRO-S form**.

### Annual Compliance of PF ESIC Registration (to be followed every year):

- 1. File monthly returns and payments by the 15th of every month.
- 2. Submit PF annual forms 3A & 6A by 30th April.
- 3. Submit ESIC half-yearly returns (Apr–Sep & Oct–Mar).
- 4. Update employee details new joiners, exits, and salary changes.
- 5. Maintain records wages, attendance, and contribution registers.
- 6. Ensure timely filings and payments to avoid penalties.
- 7. Keep employee and compliance documents ready for inspection.
