Commercial:

Property TDS Payment Package is Rs. 1500/- Includes followings

- 1. Calculation of Payment
- 2. Filing of Form 26QB (1% TDS)
- 3. Generating Chalan and Payment
- 4. Generating Form 16A

Documents Requirement for Property TDS Payment (26QB):

- 1. PAN Card of Buyer & Seller
- 2. Aadhar Card of Buyer & Seller
- 3. Address of Property

Minimum Requirement for Property TDS Payment Formation:

- 1. Applicable: When property value ≥ ₹50 lakh.
- 2. Buyer's responsibility: Buyer must deduct TDS, not the seller.
- 3. TDS Rate: 1% of total sale value.
- 4. PAN of Buyer & Seller Both must be valid.
- 5. No TAN required Only PAN is enough.
- 6. Payment Form: Use Form 26QB (online on TIN/NSDL portal).
- 7. Payment Due Date: Within 30 days from the end of the month of deduction.
- 8. TDS Certificate: Issue Form 16B to seller within 15 days of payment.
- 9. Mode of Payment: Online through net banking or challan generation.
- 10. Penalty: Late payment attracts interest & late fee u/s 234E.

Annual Compliance of Property TDS Payment (to be followed every year):

- a. Deduct 1% TDS on property value (if ₹50 lakh or more).
- b. Deposit TDS via Form 26QB within 30 days of month of deduction.
- c. Issue Form 16B (TDS certificate) to seller within 15 days of payment.
- d. Verify PAN details of both buyer and seller before filing.
- e. Keep proof Form 26QB acknowledgment, payment challan, and Form 16B.
- f. Reconcile TDS with Form 26AS annually.
- g. Pay interest/penalty if TDS is not deducted, paid, or filed on time.
