#### **Commercial:**

Property Valuation Charges Depends on property which starts from Rs. 2000 to Rs. 25000/-

#### **Documents Requirement for Property Valuation:**

- 1. Aadhar Card of Applicant
- 2. PAN Card of Applicant
- 3. Ownership Proof (Tax Bill or Electricity Bill)
- 4. Index Copy/ Purchase Agreement
- 5. List of Furniture and Attached assets
- 6. Email and Mobile Number

# **Minimum Requirement for Property Valuation Formation:**

- 1. Owner Details Name, address, ID/PAN, and ownership proof.
- 2. Property Details Address, type (residential/commercial/land), plot/survey number.
- 3. **Description** Land area, built-up area, age, structure, and condition.
- 4. **Documents** Title deed, tax receipt, EC, utility bills, and approved building plan.
- 5. **Photos** Clear images of exterior, interior, and surroundings.
- 6. Valuation Method Based on market value, guideline rate, or replacement cost.
- 7. **Valuer Details** Name, registration number, signature, seal, and date.
- 8. **Final Valuation** Land value + building value = total property value.
- 9. **Certification** Report certified by a registered valuer or chartered engineer.
- 10. **Currency** Value shown in INR (and foreign currency if required).

### Annual Compliance of Property Valuation (to be followed every year):

- 1. Update property ownership details and verify title documents.
- 2. Reassess market value based on current local property rates.
- 3. Inspect property condition, structure, and maintenance status.
- 4. Revise land and building valuation according to latest rates.
- 5. Update supporting documents such as tax receipts and utility bills.
- 6. Obtain a fresh encumbrance certificate (EC) for clear title confirmation.
- 7. Take updated photographs of the property for valuation records.
- 8. Get valuation certified by a registered valuer or chartered engineer.

- 9. Record and maintain copies of previous valuation reports for comparison.
- 10. Submit or present the updated valuation report wherever required (bank, CA, visa, or audit).
