- 2. Form 26-Q Filing: Rs. 2000/- Per Quarter

### **Minimum Requirement for TDS Return Filing Formation:**

- 1. TAN Mandatory for all deductors.
- 2. PAN Of deductor and deductees.
- 3. TDS deduction details Amount, date, and section.
- 4. Challan details (CIN) For deposited TDS.
- 5. Forms: 24Q (salary), 26Q (residents), 27Q (non-residents), 27EQ (TCS).
- 6. DSC Required for companies.
- 7. File quarterly via TRACES/NSDL portal.
- 8. Due dates: 31 Jul, 31 Oct, 31 Jan, 31 May.
- 9. Penalty: ₹200/day for late filing (u/s 234E).

### Annual Compliance of TDS Return Filing (to be followed every year):

- 1. **Deduct & deposit TDS monthly** by the **7th of next month**.
- 2. File quarterly TDS returns 31 Jul, 31 Oct, 31 Jan, 31 May.
- 3. Issue TDS Certificates Form 16 (salary) & Form 16A (others).
- 4. Verify challans & PAN details before filing.
- 5. Reconcile TDS with Form 26AS / AIS.
- 6. **Correct errors** via revised return if needed.
- 7. Maintain TDS records for audit & compliance.
- 8. Pay interest/penalty for late deduction or filing if applicable.
